

BCA Payment Options

Quick reference guide



BANK TRANSFER

For faster payments and no queue, pay using bank transfer

- Please always quote the BCA invoice number or registration number as payment reference



DEBIT CARD ONLINE

For faster payments and no queue, pay online using your debit card

- Maximum value: £20,000
- UK issued debit cards only
- Invoice or MyBCA login required



DEBIT CARD AT BRANCH

For faster payment in branch

- Maximum value: £50,000
- Invoice required
- Passport or driving licence identification required for signature only transaction



CREDIT CARD AT BRANCH

Use your MasterCard or Visa card in your local branch

- Maximum value: £50,000
- Passport or driving licence identification required for signature only transactions
- Only one credit card per vehicle and transaction



- Cash payments can be made at BCA auction centres, but these are subject to limits and restrictions
- Cash is not accepted on vehicles purchased within LeasePlan sale sections
- Cash payment over HSBC counters to BCA is not permitted
- Cash payments incur a fee of 1.25% + VAT

BCA reserves the right to refuse to accept cash or other payments and/or require additional information before accepting payment (regardless of the amount involved).

To keep our auction centres full of fresh, used vehicle stock for you, all buyers are required to pay promptly for vehicles purchased, in accordance with our Conditions of Entry and Sale.


